(I) The Company has entered the Subscription Agreements dated 29 September 2010 (as disclosed in the Company's announcement of 4 October 2010) to issue convertible notes in the aggregate principal amount of HK\$30,000,000. Based on the initial conversion price of HK\$ 0.25 per conversion share (subject to adjustments), a total of 120,000,000 new shares to be allotted and issued upon exercise of the conversion rights to the convertible notes.

(II) The Company has entered into the Agreement on 31 May 2011 (as disclosed in the Company's announcement of 1 June 2011) pursuant to which the Company will issue of 93,360,000 consideration shares to the Target Company at an issue price of HK\$0.25 per consideration share to satisfy the Consideration.
