A total of 194,843,836 Shares were held by the Shareholders who attended and voted for or against the resolutions at the Annual General Meeting. No Shareholder was entitled to attend and vote only against any resolutions at the Annual General Meeting. No Shareholder was required to abstain from voting in respect of any resolution proposed for approval at the Annual General Meeting.
