On 30 December 2013 (after trading hours), the Company and the vendor have entered into the fourth supplemental agreement for further amending certain terms of the agreement (as amended by the supplemental agreement dated 30 March 2012, the second supplemental agreement dated 27 December 2012 and the third supplemental agreement dated 30 June 2013), pursuant to which it has been agreed that the long stop date for fulfilment of the conditions precedent to the completion is further postponed from 31 December 2013 to 31 December 2014.
