The Board is pleased to announce that the English name of the Company has been changed from “Vitop Group Limited” to “Share Economy Group Limited” and the Chinese name “共享經濟集團有限公司” as the secondary name of the Company has been adopted in place of the Chinese name “天年集團有限公司” which had been adopted for identification purpose only.

The stock short name for trading in the Shares on the Stock Exchange will be changed from “VITOP GROUP” to “SHARE ECON GP” in English and from “天年集團” to “共享經濟集團” in Chinese with effect from 9:00 a.m. on 25 November 2016. The stock code of the Company on the Stock Exchange will remain unchanged.

Reference is made to the announcement of Share Economy Group Limited (formerly known as Vitop Group Limited) (the “**Company**”) dated 24 August 2016 and the circular of the Company dated 14 September 2016 (the “**Circular**”) in relation to, among other things, the proposed change of name of the Company. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless defined otherwise.

## **CHANGE OF COMPANY NAME**

The Board is pleased to announce that subsequent to the passing of a special resolution in relation to the Change of Company Name by the Shareholders by way of poll at the EGM held on 27 October 2016, the Certificate of Incorporation on Change of Name has been issued by the Registry of Companies in the Cayman Islands on 27 October 2016, certifying that the Company has changed its English name from “Vitop Group Limited” to “Share Economy Group Limited” and the adoption of the Chinese name “共享經濟集團有限公司” as the secondary name of the Company, both with effect from 27 October 2016.

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 21 November 2016, confirming the registration of the new name of the Company “Share Economy Group Limited 共享經濟集團有限公司” in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

## **EFFECT ON CHANGE OF COMPANY NAME**

The Change of Company Name will not affect any of the rights of any Shareholder or the Company’s daily business operation and its financial position. All existing share certificates in issue bearing the Company’s former name will continue to be valid evidence of legal title to the securities of the Company and will continue to be valid for trading, settlement, registration and delivery purposes.

Accordingly, there will not be any arrangement for the free exchange of the existing share certificates for new certificates bearing the new name of the Company. New share certificates of the Company will be issued under the new name of the Company in any subsequent issue of Shares after the Change of Company Name has become effective.
